- Dogovor velja za vse vidike dela pri zagotavljanju odgovornosti za ustrezne preiskave in reševanja vprašanj v zvezi z natančnostjo ali integriteto katerega koli dela prispevka / Agreement to be accountable for all aspects of the work in ensuring that questions related to the accuracy or integrity of any part of the work are appropriately investigated and resolved.
